# Board Minutes Summary - March 27, 2018

#### **Open Forum**

Members asked questions or provided comments on general landscape and maintenance matters. All questions were answered to the satisfaction of the Members present. Members remained to observe the remainder of the meeting.

#### Presidents Message on page 1

#### Chief Financial Officer's Report

The Operating Account balance is \$44,638. The total Reserve Account balance is \$548,326. The Accounts Receivable balance is \$36,311. Monthly Income was \$62,553 with expenses of \$52,396. Total assets as of 2/28/2018 is \$630,671. A motion was made, seconded and carried to approve the financial report as presented for filing pending independent financial review.

#### Landscape

The Westwind Tree Service is in process of performing approved tree trimming and tree removal. Completion of the work is scheduled for next week.

Chuby Landscaping is in process of performing approved brush abatement for the areas commonly called the "lower" and "upper jungles". This is the canyon area running in between and behind homes on Columbine and Larkspur. The work performed to date is to the full satisfaction of the Board. Completion of the brush abatement is scheduled for next week.

#### Governing Documents Review Committee

The committee consists of Diane Altamirano and Becky Schooler as Co-Chairs, Cathy Santangelo as Board Liaison, Becky Schooler is the Secretary. Carl Berry, Harry Houghton, Bob Massey, Rebecca Ocain and Tom Richardson are Members. Ann Cole is the alternate. The committee will schedule a meeting soon to begin review and discussion of the CCR's.

#### **Unfinished Business**

The Board reviewed several competitive bids to prep, prime and paint the 16 tennis court light fixtures and upper poles and common area metal hand railings. After further review and discussion, a motion was made, seconded and carried to approve the proposal from Keith Monroe Painting for a cost of \$2,750.

ProTec Building Services has nearly completed approved repairs to the pool pump room to prevent water backup from entering the clubhouse/card room and causing damage. Management has coordinated this work with the pool vendor for successful completion with the least inconvenience to the Members. Proposals for needed repairs to the damaged card room will be obtained.

#### **New Business**

Weir Asphalt is tentatively scheduled to seal all of the asphalt streets throughout the community On May 7 through May 11 in five separate phases. Notices will be issued to all residents approximately 4 weeks prior to scheduled work with a reminder notice issued 1 week prior to scheduled work.
