President's Message

We are almost at the half way point of summer and temperatures are increasing. Last month I reported the well saved us \$8,050. On the most recent bill, we saved \$11,359.31 compared to June 2014. If these savings continue at the current rates, we will have recovered the total cost of the well by April 2016. I would like to personally thank Bob Massey for his work in preparing the well site for erosion control and overseeing the well's operation in Casey Myers absence, Jim Hook for compiling the usage data and Casey Myers for his work in securing an agricultural rate on electricity. Along with Kolton Gustafson, these volunteers are an example of what can be accomplished when we get volunteers who are willing to commit time to our community.

Last month the Board approved hiring a road consultant, Monty Wilde, from AMC Asphalt Management. The inspection and report, with recommendations, are now complete. PHOAC and the Board are in the process of reviewing the report and will convene the Road Committee in August to review the findings and recommendations. As we transition into finalizing our plan, a communitywide meeting will be held so homeowners can see what the Board is recommending. An announcement of the meeting will be made well in

We recently had an audit of our energy use. This service was coordinated by Mary and was free of charge. As a result of Mary's efforts, SDG&E sent out Matrix Energy Services to upgrade all of the clubhouse and maintenance garage

Board Minutes Summary - July 28, 2015

Financial Report

The Board reviewed the report for period ending 6/30/15. The Operating account balance is \$3,836.08, the Reserve Account balance is \$849,167.56 and the Accounts Receivable balance is \$16,595.95. Pre-paid Income totaled \$35,646.80. Monthly Income was \$54,860.00 with expenses of \$101,919.00 for net of (-\$47,059). The net loss is directly attributed to the well installation cost. When factoring in the cost of the well, the Association is approximately \$25,000 under budget year to date. A motion was made, seconded and carried to approve the Financial Report Pending independent financial audit.

A draft of the 2016 Reserve Study has been tabled for approval at the next meeting pending further review and discussion.

Presidents Report

The Association Vice President reported we are experiencing a large savings in water costs due to the new well being on-line. A big thanks to Jim Hook, Casey Myers and Bob Massey for all of their time and dedication to the success of the well project. A meeting is scheduled with the asphalt consultant, the Board and the Road Committee on August 18, 2015. SDG&E has recently completed an energy audit and has replaced approximately 90 light bulbs with more energy efficient light bulbs. A report has been provided with recommendations for additional energy savings.

Committee Reports

Landscaping – Pam Whitfield reported the Board and Committee are working with the new landscape supervisor to address all areas of concerns. The committee recommends planting rosemary along the slope next to the well to aid in erosion control.

Water Usage/Conservation and Well – Bob Massey provided a report for this period. A big thanks again was given to Casey Myers for all of his time and commitment in adjusting the programming for optimal performance. The water usage saving for the 1st full month of operation was 1,341,912 gallons, saving the Association approximately \$11,000.

2015 Annual Meeting of Members & Election – The Association's Annual Meeting of Members & Election is scheduled for Tuesday September 22, 2015 at 7:00 p.m. There are three (3) board seats up for election. The three (3) candidates receiving the most votes will each serve a two (2) year term.

New Business

Pool Area Monitoring Proposals – The Board reviewed proposals for monitoring the pool/spa area. At this time the Board tabled this item pending receipt of additional information on incidents to determine if the cost of this service is warranted.

Solar Lighting – The Board has tabled this item due to lack of funding at this time.

Adjournment

The next regular board of directors meeting will be held Tuesday, August 25, 2015 at 7 p.m. in the Crown Hills Community Clubhouse.
