

Disaster Preparedness

Seventy-Two hours. That's how long officials say it may take before help begins to arrive if a widespread disaster were to strike San Diego County. Preparing for an emergency can make all the difference in safeguarding the lives of family, friends, and neighbors. The following information is presented to assist you in preparing for an emergency or disaster.

San Diego's Emergency Alert System radio system is KOGO/AM 600, which will broadcast official information in English. The backup station is KLSD/AM 1360.

Do Not call 911 Except To Report An Emergency Call 211 for non emergency information during a disaster or use their web site at

www.211sandiego.org if available. Keep calls to a minimum especially after an earthquake. There may be a delay in getting a dial tone but do not depress the switch hook since this could increase the delay. If you hear a fast busy signal, all circuits are busy. Hang up and try your call later.

Clean Up After Your Pet!

There has been a recent increase in pet waste being left in the landscaping. There are dog bag stations provided for you to easily clean up after your pet.

Any resident caught not cleaning up after their pet is subject to possible fines. Please be courteous and clean up after your pet.

Financial Report

The Financial Report for period ending October 31, 2015. The Operating Account balance is \$56,978.34, the Reserve Account balance is \$867,610.35 and the Accounts Receivable balance is \$8,612.56. Pre-paid Income totaled \$21,817.75 for this period. Monthly Income for this period was \$57,733.00 with expenses of \$43,373.00 for a net of \$14,529.00. Total assets as of October 31, 2015 are \$934,173.00. The 2015 Financial Review and Tax Preparation will be completed by Terry J. Tagwerker, CPA.

Committee Reports

Architectural

The Chair of the Committee Pat Bowles provided a brief update.

Landscape

- ✓ A walk-thru inspection of the common landscape of the community was conducted on 11/3/2015.
- ✓ Pacific Green has been tasked with submitting a plan to mitigate erosion.
- ✓ Sandbags are available for residents by contacting the community office.
- √ 7 Eucalyptus trees are being removed along Larkspur that are damaging the asphalt along with one
 other dead Eucalyptus on Victoria Terrace. There are trees along the concrete drainage swales that will
 be inspected to determine if any damage is occurring to the swale.
- ✓ The irrigation system has been inspected, marked and adjusted with good results.
- ✓ The Landscape Committee provided a draft charter and procedures along with long term goals for the board to review.
- ✓ The Board reviewed a proposal from Aztec Landscape to hydro-seed a steep slope located behind homes on Snapdragon. This item has been tabled pending further review and discussion.

Well Water Operations

Casey provided a brief report for this period. 496,200 gallons of water was pumped between October 26th and November 23rd at a cost of \$578 for electricity. Approximately \$3,400 in water costs were saved during this period.

8. Architectural Standards

- 8.1 General Standards
- 8.1 (a) With the exception of minor projects noted in 8.1 (b) below, construction, alteration, addition, modification or reconstruction to the exterior of the home lot must be approved by the ARC before work is commenced. This includes work on roofs, siding, patios, decks, fencing, walls, garages, driveways and major landscaping work. When the extent of the work is in question, ARC approval should be requested. (Note: Artificial grass/turf installation requires ARC approval and samples of the material to be installed must be provided.) Painting of grass is not allowed with the exception that specialized "turf paint" of a natural grass green color may be used on seasonally faded grass/turf. Indoor/Outdoor carpeting is prohibited for use as a lawn cover and may not be used as a substitute for grass.
- 8.1 (b) Minor projects, such as the following, may be commenced and completed without ARC approval:
 - (1) Repairs to existing improvements
 - (2) Rejuvenation of grass lawns
 - (3) Replacement of existing plantings with similar plantings
 - (4) Tree removal on the Owner's property
