Board Minutes Summary - June 28, 2022

Approval of Previous Meeting Minutes

- The Board reviewed the Open Session Meeting Minutes of May 24, 2022. A motion was made, seconded, and carried (MSC) to approve the Minutes as presented.
- The Board reviewed the Executive Session Meeting Minutes of May 24, 2022, in which the Board reviewed the violation log, the delinquent account log, reviewed homeowner correspondence, reviewed community brow ditch repair needs and held a due process violation hearing. MSC to approve the minutes as presented.

Financial Report

- **Period Ending 5/31/2022:** The Operating Account balance is \$32,581. The total Reserve Account balance is \$719,824. The Accounts Receivable balance is \$6,765. Monthly Income was \$78,670 with expenses of \$93,038. Total assets are \$759,371. MSC to approve the financial report as presented for filing pending independent financial review.
- **Reserve Study 2023 Update:** The Treasurer and Management have working and updating the reserve study. A meeting was held with the reserve specialist on Thursday 5/19/2022 to review the reserve study and inspect components throughout the property. A draft copy of the reserve study has been provided to the board for review. MSC approve the draft reserve study as presented. The study indicates that the reserve account is approximately 67% funded at this time.

Committee Reports

- Architectural: Committee Chair Michael Beraud was not present but did provide a report for this period. There were five (5) new requests received. One (1) received an initial review and approval. Four (4) are pending. Twelve (12) were finalized at this time.
- **Landscape:** The Board reviewed an inspection report for this period. All minor maintenance is performed during the regular maintenance schedule. Any major items or issues that come up are put before the board for review and consideration at each posted meeting. Brush abatement continues in the canyon areas surrounding the community.

Unfinished Business

Gym Equipment Replacement Proposals: Proposals are being obtained to replace the current flooring inside the gym prior to replacing any equipment. This item shall remain on the agenda pending receiving additional proposals.

New Business

Exterior Plumbing Modification: The Board reviewed a proposal from JC Plumbing to modify a hose bib, ball valve and copper pipe so it does not protrude into the sidewalk for a cost of \$1,095. This item has been tabled at this time.

2022 Annual Meeting & Election: The Annual Meeting of Members and Election is scheduled for Tuesday 9/27/2022 at 6:00 p.m. in the community clubhouse. There are two (2) board seats up for election. Candidate Forms have been distributed to the membership. Once the candidate deadline has passed and if there are no more candidates than open positions, the Board may vote to seat the candidates by acclimation.

Homeowners Open Forum Members asked questions regarding the proposed special assessment. Any questions were answered to the satisfaction of the Members present.

Hot Topic - Westwind

All landscape crew members now wear vests identifying themselves as Westwind employees. Their work vehicles now have a sign on their doors to identify them. Please be aware that occasionally you will see some of our landscape crew members wearing complete facial coverings. This is due to skin allergies and to protect themselves from the sun. There is a new law in California that requires all waste generators to recycle organics, which includes food waste, green waste, landscape and pruning waste, nonhazardous wood waste and food-soiled paper products.

Get Familiar with Organics Recycling

Toss your unfinished food scraps, skins and peelings into your organics recycling cart. We will pick it up, take it to our composting facility and turn it into compost that will go right back into the community.

The Law

Senate Bill 1383 was signed into law to combat climate change and reduce landfill methane emissions from decomposing organic materials. Methane is a climate super pollutant, 84 times more potent than carbon dioxide. Organics like food scraps, yard trimmings, paper and cardboard currently make up 50% of what Californians dump in landfills. By diverting organic waste, we can significantly reduce local air emissions.

What Does It Mean?

This law requires your waste hauler to collect your organic waste, including food waste, and dispose of it in a more sustainable manner, instead of simply taking it to the landfill.

Who Is Affected?

Everyone. Residents, multi-family properties and complexes, businesses, schools and public agencies all need to comply with the law and enroll in an organics recycling program.

Sustainability in Action

What is SB 1383?





In September 2016, governor signed into law SB 1383, establishing methane emissions reduction targets in a statewide effort to reduce emissions of shortlived climate pollutants (SLCP) in various sectors of California's economy. SB 1383 established targets:

50% Reduction of organic waste disposal in landfills by 2020

75% Reduction of organic waste disposal in landfills by 2025 **20%** Rescue of currently wasted surplus food by 2025

Will organic waste be composted?

Yes, the organic material will be composted.

What is food rescue?

For large food service businesses, edible food must be donated to food recovery organizations instead of thrown away. This will help feed the almost 1 in 4 Californians without enough to eat.

Who is affected?

Everyone. Residents, multifamily properties and complexes, businesses, yard waste exempt residents and public agencies will all need to comply with the law and have an organics recycling program.

When will the organics program begin?

There are many regulations that your city has to comply with in SB 1383. Your city is currently in negotiations with Republic Services regarding rates for weekly residential organics collection and an implementation plan to meet these new regulations. Your city council will review all the information at a future city council meeting. Once approved, you will be notified when these changes will begin. Your city is expecting to launch its full organics recycling program for residents in spring 2022.
