Board Minutes Summary - October 26, 2021

Approval of Previous Meeting Minutes The Board reviewed:

- Annual Meeting Minutes of September 28, 2021, for accuracy. A motion was made, seconded, and carried (MSC) to approve the Minutes as presented for approval at the next scheduled Annual Meeting of Members & Election.
- ✓ Organizational Meeting Minutes of September 28, 2021. MSC to approve Minutes as presented.
- ✓ Open Session Meeting Minutes of September 28, 2021.MSC to approve Minutes as presented.
- Executive Session Meeting Minutes of September 28, 2021, in which the Board reviewed the violation log, the delinquent account log, reviewed homeowner correspondence, and met with a Homeowner upon their request. MSC to approve Minutes as presented.
- ✓ Open Session Meeting Minutes of October 11, 2021. MSC to approve Minutes as presented.

Financial Report

Period Ending 9/30/2021: The Operating Account balance is \$72,038. The total Reserve Account balance is \$778,874. The Accounts Receivable balance is \$5,705. Monthly Income was \$63,617 with expenses of \$74,179. Total assets are \$856,819. MSC to approve the financial report as presented for filing pending independent financial review.

2022 Draft Budget: The Board of Directors has spent the past few months reviewing and discussing next year's budget. During this process, the Board took into consideration the needs of the community. Costs for the month-to-month operations of the Association have increased in all categories of service provided here at Crown Hills. Brush abatement has been increased once again to reduce fire liability and to be able to continue to obtain fire insurance for the community. Reserve funding has been increased to assure funds are available when the time comes to replace common area components. MSC to approve the 2022 budget as presented to be effective beginning 1/1/2022.

2021 Independent Financial Review: Pursuant to California Civil Code, a review of the Association's Financial Statements must be performed by an independent and licensed California CPA.MSC to approve the proposal submitted by Sonnenberg & Company, CPAs to perform the financial review, cost of \$1,250.

Committee Reports

Architectural: Committee Chair Mike Wilmers was present and provided a report for this period. There were fifteen (15) new requests received. Thirteen (13) received an initial review and approval. Twenty-Eight (28) finalized were reviewed and approved.

Landscape:

- ✓ Inspection report for this period. All minor maintenance is performed during the regular maintenance schedule.
- ✓ The Board is in process of obtaining competitive proposals for brush abatement in specific areas of the community per a request from the Alpine Fire Marshall. This item shall remain on the agenda for further review and consideration.

Pool/Spa: All equipment is functioning well and no other issues to report this period.

Unfinished Business

County Health Update: There are no new county updates for this period.

Tennis Court Maintenance/Repair: Ferandell Tennis Courts, Inc. has completed the resurfacing of the tennis courts and replacing the old and damaged wind screens on both courts. A new pickleball net system has also be installed during this project. All work has been completed to the full satisfaction of the Board.

New Business

Air Purifier Proposal Review: The Board reviewed a proposal from JC Plumbing to install three (3) new ionization air purifiers to all 3 HVAC systems in the clubhouse building. After further review and discussion, MSC to approve the proposal, cost of \$2,925.

Homeowners Open Forum

Members were free to speak on any matter of interest to the Community. Questions were raised regarding Halloween community events. Any questions were answered to the satisfaction of all Members present.
