Board Minutes Summary - September 26, 2023

Approval of Previous Meeting Minutes

- ✓ The Board reviewed the Open Session Meeting Minutes of August 22, 2023. A motion was made, seconded, and carried (MSC) to approve the minutes as presented.
- ✓ The Board reviewed the Executive Session Meeting Minutes of August 22, 2023, in which the Board reviewed the violation log, reviewed the delinquent account log, reviewed homeowner correspondence, reviewed the security monitoring report and met with CC&R committee members and held due process violation hearings. MSC to approve the minutes as presented.

Financial Report - Period Ending 8/31/2023: The Operating Account balance is \$18,510. The total Reserve Account balance is \$845,868. The Accounts Receivable balance is \$2,500. Monthly Income was \$76,631 with expenses of \$90,121. Total assets are \$866,879. MSC to approve the financial report as presented for filing pending independent financial review.

Committee Reports

Architectural: Committee Chair Michael Beraud was present and did provide a report for this period. There were nine (9) new requests received for items such as solar, windows and fencing. Eight (8) received an initial review and approval, one (1) is pending, and fourteen (14) have been finalized at this time.

Landscape: A report was provided by Westwind covering the month of August/September, 2023. All minor landscape maintenance is performed during the regular landscape maintenance schedule. Any major items or issues that come up are put before the board for review and consideration at each posted meeting. Brush abatement is continuing throughout the canyon areas of the community as needed. The Board has approved several erosion control and enhancement project proposals submitted by Westwind Landscape for a total cost of \$4,140.

Pool/Spa: The pool/spa area has seen very heavy use during these hot months. The pool will be shut down beginning Monday, September 25, 2023 in order to perform needed repairs.

Unfinished Business

Clubhouse Flat Roof Replacement: Raneri & Long Roofing has completed the replacement of the flat portion of the community building roof to the full satisfaction of the board.

Pool Solar Water Heating: Precision Solar has completed the replacement of the aging pool solar water heating equipment. The new equipment is much more efficient than the previous equipment and should allow for an extended swimming season.

Asphalt Speed Humps: Eagle Paving has scheduled the installation of three (3) speed humps approved by Alpine Fire Protection along a section of Larkspur Drive on September 28th. Residents have been previously notified.

New Business

Tennis Court Lighting: A proposal was received from RPL Electric to replace the 16 tennis court lights with new higher lumen rated lighting. This item will remain on the agenda pending further review and discussion.

Community Pest Control: Due to continuing service issues with the current pest control vendor, a proposal has been requested from Armor Pest Control, Inc. for squirrel and gopher control. After further review and discussion, MSC to approve the proposal as submitted for a cost of \$815 per month. A contract termination notice will be issued to the current vendor.

Homeowners Open Forum - Members were free to speak on any matter of interest to the Community. Questions regarding minor community landscape issues were answered to the full ability of the Board. Members thanked the Board for all they do for the community.
