# Annual Board & Elections Meeting Summary - September 22, 2020

#### Presidents Message on page 1

#### Quorum Establishment and Call To Order

A quorum consisting of at least 33 1/3% of the Members (111) must be present or represented by secret ballot. The Inspector of Election announced that a quorum was met with 133 ballots received. The ballot tabulation volunteers were then instructed to open and tabulate all ballots while the meeting continued.

#### Approval of Previous Meeting Minutes

Open Session Meeting Minutes of August 25, 2020. A motion was made, seconded, and carried to approve the Minutes as presented.

Executive Session Meeting Minutes of July 29, 2020 in which the Board reviewed the violation log, the delinquent account log, reviewed homeowner correspondence and reviewed any county health guidelines updates. A motion was made, seconded, and carried to approve the Minutes as presented.

#### Financial Report

**Period Ending 8/31/2020** The Operating Account balance is \$78,861. The total Reserve Account balance is \$692,915. The Accounts Receivable balance is \$11,422. Monthly Income was \$63,421 with expenses of \$65,962. Total assets are \$783,562. A motion was made, seconded, and carried to approve the financial report as presented for filing pending independent financial review

**2021 Draft Budget Discussion** The Association Treasurer and Management have spent the past several months researching, reviewing, and updating the draft 2021 budget to assure the draft is as accurate as possible. It was announced that there would be a small increase in the monthly assessment to assist in covering costs associated with annual brush and weed abatement due to the high fire risk area of the community. This item will remain on the agenda for further review and approval.

#### Committee Reports

**Architectural** Committee Chair Mike Wilmers was present and provided a report. There were ten (10) new requests received. Nine (9) had an initial review and approval. None were finalized at this time.

**Landscape** The Board reviewed a proposal from Westwind to prepare the planter area in the middle of the community center parking lot and install new soil fabric, irrigation, and brown rock mulch. A motion was made, seconded, and carried to approve the proposal as submitted for a cost of \$3,875.

The Board reviewed a proposal from Westwind to prepare the planter area at the corner area next to the gym HVAC unit at community building and install new soil fabric, 4 succulents, and brown rock mulch. A motion was made, seconded, and carried to approve the proposal as submitted for a cost of \$325.

#### Unfinished Business

**County Health Update** The Board discussed any updates from the state and county. Traditional Halloween practices are not allowed under current guidelines. Monitoring will be scheduled on Halloween as is normal practice.

#### **New Business**

Community Garage Sale Discussion This item has been tabled.

**Proposed Photovoltaic** The Association CFO presented a short review regarding the possibility of installing a photovoltaic solar system to provide electrical for the pool equipment and the clubhouse area. This item will remain on the agenda for further review, discussion, and consideration.

#### Homeowners Open Forum

Members were present to discuss new proposed paint schemes, landscape, proposed gating of the community and minor maintenance matters.

#### Announcement of Election Results

The Inspector of Election announced that Casey Myers and Ronald Torres were re-elected to the Board of Directors to serve 2 years. The Inspector of Election and the Association President thanked all of the Candidates and Homeowners for attending this evening.

# **Guidance for Celebrating Halloween during the COVID-19 Pandemic**



To minimize the spread of COVID-19 and ensure children have a fun, safe Halloween, the County of San Diego offers guidance for the most common activities to protect you and your loved ones.

### **Halloween Activities**

**Not Allowed** (in-person gatherings and events are currently not allowed under the County of San Diego Public Health Order)

- In-person gatherings, events, or parties with non-household members are not permitted, even if they are conducted outdoors, since maintaining 6-feet of distance between participants cannot be easily maintained.
- Carnivals, festivals, petting zoos, and live entertainment are not allowed because frequent interaction with high-touch surfaces by children and participants increase the risk of infection to the community.

#### **Not Recommended**

- Close contact, door-to-door trick-or-treating or "trunk-or-treating," and leaving bowls of candy for others to grab is not recommended, because it is difficult to maintain proper social distancing guidelines.
- Haunted Houses are not recommended because they put an increased amount of people in typically tight, poorly ventilated areas that make it difficult to maintain 6-feet of distance from others.

#### Recommended

- Online parties/contests (e.g., costume or pumpkin carving) and drive-through events and car parades.
- Dressing up homes and yards with Halloween-themed decorations.
- Halloween movie nights with your own household or at drive-in theaters.
- Pumpkin patches where people use hand sanitizer and maintain 6-feet of distance from others.

#### Safer Alternatives

Many traditional Halloween activities can be high-risk for spreading viruses. There are several safer, alternative ways to participate in Halloween listed below.

- Make fall recipes and crafts as a family for creative dinners and spooky decorations.
- Participate in drive-through events or contests where individuals dress up or decorate their vehicles and receive scores from "judges" that are maintaining appropriate physical distance.
- Visit pick-your-own fruit/vegetable operations that follow <u>California Department of Food and Agriculture</u> guidelines.
- Participate in one-way trick-or-treating, where individually wrapped goodie bags are lined up for families to grab while continuing to social distance (such as at the end of a driveway or at the edge of a yard).
- Consider distributing treats other than candy, which parents can then sanitize before giving to kids: stickers in cellophane packaging, pencils, mini pumpkins, erasers, etc.

#### **Personal Protection Measures**

However you celebrate, please continue to follow the <u>County of San Diego Public Health Order</u>, <u>California Department of Public Health Guidance</u> and the <u>Centers for Disease Control and Prevention Halloween Guidelines</u>, maintain safe distance and wear a face covering to keep children and adults safe. To stay safe during the 2020 Halloween holiday, please remember to:

- Wash or sanitize your hands often.
- · Clean frequently touched items regularly.
- Avoid close contact stay at least 6 feet away (3 or more adult steps) from all other people who are not part of your own household.
- Avoid indoor spaces that don't allow for easy distancing of at least 6 feet between you and others.
- Correctly wear a face covering to prevent disease spread when outside your home and around others that are not part of your household.
- Stay home and away from others, if you are sick, or you have been in contact with someone who is sick with or has symptoms of COVID-19.
